

1 Amend 2 Cal. Code Regs. Section 18438.8 as follows:

2 **§ 18438.8. Disclosure Under Government Code Section 84308.**

3 (a) An officer who is required by ~~Government Code~~ section 84308(c) to disclose the
4 receipt of a contribution shall ~~make the disclosure~~ disclose any disqualifying contribution the
5 officer knows of or has reason to know of, either orally or in writing, on the public record at the
6 beginning of a public ~~hearing~~ meeting in a proceeding involving the license, permit, or other
7 entitlement for use, if a ~~hearing~~ meeting is held. However, in the circumstance where the officer
8 learns of the contribution during the public meeting, the officer shall make the disclosure on the
9 public record prior to continuing to take part in the proceeding. If there is no public ~~hearing~~
10 meeting, ~~the written~~ disclosure shall be entered into ~~the written record of the proceeding the~~
11 agency's official records. The officer, or an employee of the agency on behalf of the officer, shall
12 disclose that the officer has received contributions from a party, participant, or agent of a party or
13 participant, greater than \$250 within the preceding 12 months and the name(s) of the
14 contributor(s).

15 (b) Any party to a proceeding pending before an agency ~~under Government Code section~~
16 ~~84308(a)~~ shall disclose on the record of the proceeding the names of any persons whose
17 contributions are required to be aggregated, if the person has made a contribution to any officer
18 of the agency ~~as defined in Government Code section 84308(a)(4).~~ ~~The disclosure shall be made~~
19 ~~at the time the application is filed, or the proceeding is otherwise commenced, if the contribution~~
20 ~~was made during the twelve month period preceding the filing of the application or~~
21 ~~commencement of the proceeding, or no later than 30 days after the contribution is made if the~~
22 ~~contribution is made at any stage during the proceeding.~~ The party shall disclose the amount of
23 the contribution(s) made within the preceding 12 months and the names of the contributors,
24 including contributions made by an individual required to be aggregated with the party or the

1 party's agent under Section 82015.5. The party shall make the disclosure:

2 (1) On the date the party files the application or other request initiating the proceeding.

3 (2) For a contribution made at any stage during the proceeding, within 30 days of making
4 the contribution, or the date on which the party makes its first appearance before or
5 communication with the agency regarding the proceeding following the contribution, whichever
6 is earliest.

7 (3) If an agent of a party makes an appearance before or communication with the agency
8 subsequent to the party's disclosure, the party or agent must disclose the agent's identity on the
9 date of the agent's first appearance before or communication with the agency following the
10 party's disclosure.

11 ~~(c) The disclosure shall include the name of the party and any other person making the~~
12 ~~contribution, if any, the name of the recipient, the amount of the contribution, and the date the~~
13 ~~contribution was made.~~
