- This filing schedule is prepared for the special election only. Committees making payments in connection with other elections may trigger other reporting deadlines.
- \* Period Covered: The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- E-Filer: A state committee that has received contributions or made expenditures totaling \$25,000 or more.
- Form 460: All state committees, including e-filers, must also file paper reports.
- Paper Filings: All paper filings may be filed by first class mail unless otherwise noted.
- Forms 496 and 497: All reports filed online only.
- Where to File: State committees file reports with the Secretary of State.
- Filing Deadlines: Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to any 24-hour independent expenditure reports (Form 496) or to 24-hour contribution reports (Form 497) that are due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week and are subject to a \$10 per day late fine.
- **Penalties:** Failure to file a statement on time subjects a committee to a fine of \$10 per day on both the paper and the e-filed version resulting in a \$20 per day late fine. Failure to file a statement could result in an enforcement penalty of \$5,000 per violation.
- Contribution Limits: Refer to the contribution limits chart on the FPPC website.
- Public Documents: All statements are public documents. Campaign manuals and instructional materials are available at <a href="www.fppc.ca.gov">www.fppc.ca.gov</a>, click on the Learn link.
