Apr 26, 2018  1st Pre-Election	1/1/18 – 4/21/18	450 or 460	<ul> <li>File if contributions or independent expenditures totaling \$500 or more were made in connection with the June 5 statewide primary election.</li> </ul>
May 24, 2018 2 <sup>nd</sup> Pre-Election	4/22/18 – 5/19/18	450 or 460	<ul> <li>File if contributions or independent expenditures totaling \$500 or more were made in connection with the June 5 statewide primary election.</li> </ul>
Jul 31, 2018 Semi-Annual	* - 6/30/18	450 or 460	<ul> <li>All committees must file Form 450 or Form 460.</li> </ul>

Within 10 Business Days \$5,000 Report (Local Ballot Measure Qualification Payments)	ngoing	<u>496</u> <u>497</u>	<ul> <li>496: Report independent expenditures totaling \$5,000 or more to support or oppose the <i>qualification</i> of a single local ballot measure.</li> <li>497: Report contributions totaling \$5,000 or more to support or oppose the <i>qualification</i> of a single local ballot measure.</li> <li>Contributions Received: List all new contributions of \$100 or more received by the committee that have not been previously reported in connection with the qualification of the measure up through the date of the \$5,000 or more payment.</li> <li>Where to File: File in the jurisdiction of the local measure and not necessarily where the committee files its regular campaign statements.</li> <li>Method of Filing: File by personal delivery, e-mail, guaranteed overnight service, fax, or online, if available.</li> </ul>
Within 10 Days  Paid Spokesperson Report	ngoing	<u>511</u>	<ul> <li>File if either of the following expenditures related to an advertisement to support or oppose a ballot measure are made: 1) A payment totaling \$5,000 or more to an individual to appear in an advertisement, or 2) A payment of any amount to an individual portraying a member of a licensed occupation (i.e., nurse, doctor, firefighter). E-filers also file online.</li> </ul>
Within 48 Hours Issue Advocacy Report	21/18 - 6/4/18	<u>E-530</u>	<ul> <li>File if a payment or promise of a payment of \$50,000 or more is made during the 45 days prior to an election for a communication that identifies a state candidate being voted upon in the election but does not expressly advocate the election or defeat of the candidate. No paper copy is required.</li> </ul>

### **Additional Notes:**

- \* Period Covered: The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- E-Filer: A state committee that has received contributions or made expenditures totaling \$25,000 or more.
- Forms 450 and 460: All state committees, including e-filers, must also file paper reports. Paper reports may be filed by first class mail unless otherwise noted.
- Forms 496 and 497: All reports filed online only.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to any 24-hour Independent Expenditure Reports (Form 496) or to a 24-hour Contribution Report (Form 497) that is due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week.
- **Penalties:** Failure to file a statement on time subjects a committee to a fine of \$10 per day on both the paper and the e-filed version (e.g., \$20 per day for a late e-filed Form 460). Failure to file a statement could result in an enforcement penalty of \$5,000 per violation.

- State Contribution Limits: Refer to the contribution limits chart on the FPPC website.
- Expenditures for Local Elections: Committees making contributions or independent expenditures in connection with a local election should consult the filing schedule for that election as Forms 497 and 496 may be required. Check with the jurisdiction to determine if there are contribution limits or other restrictions.
- **Public Documents**: All forms are public documents. Campaign manuals and instructional materials are available at <a href="www.fppc.ca.gov">www.fppc.ca.gov</a>, click on Learn, then Campaign Rules.
- Multipurpose Organizations (including non-profits): A multipurpose organization that uses its general dues account to make contributions or expenditures may qualify as a major donor or independent expenditure committee and may be required to report payments on Campaign Form 461. Such an organization will qualify as a recipient committee if expenditures exceed \$50,000 in a 12-month period or \$100,000 in four consecutive calendar years. An organization that qualifies as a recipient committee may need to file reports disclosing contributors.
